# Part 2: Responsibilities for health and safety

1 Overall and final responsibility for health and safety:

2 Day-to-day responsibility for ensuring this policy is put into practice:
All Society workers. All Society workers are at all times responsible for ensuring their personal safety and the safety of others. No volunteer will be expected to undertake any task for which they feel unable, or are unwilling, to perform, or where they feel a task is beyond their level of skill or competence.
3 To ensure health and safety standards are maintained/improved, the following people have responsibility in the following areas:
Risk Assessments - on site experienced Society worker
First Aid Facilities - Matthew Vaughton
Equipment: maintenance & safety - Matthew Vaughton

- 4 All Society workers should:
- co-operate with trustees on health and safety matters;
- take reasonable care of their own health and safety; and
- report all health and safety concerns to an appropriate person (as detailed above).



# Part 3: Arrangements for health and safety

#### Risk assessment

A risk assessment will be undertaken by an experienced Society worker before all "changes of activity". See the separate OHBS Risks and OHBS Risk Assesment documents for a list of the most likely risks to be considered. A risk assessment need not always be in the form of a written document, it may, in simple	9
considered. A lisk assessment need not always be in the form of a whiten document, it may, in simple changes of activity, take the form of a mental check of the OHBS Risks document.	

### **Training**

While Society workers are expected to have familiarity with safe hand held tool working and workshop practices informal training by an experienced Society worker will be provided on a case-by-case basis.

#### Consultation

The Society will consider health and safety matters at regular trustees meetings and annually at the Society AGM.

#### Evacuation

The Society will ensure emergency evacuation routes and all fire regulation requirements are met at all times at work locations the Society manages. The Society will adhere to the requirements for evacuation routes at all other locations at which it operates.
